Instructions for Use:

1. Place a few drops of E-Rinse ORAL RELIEF on clean finger, Q-tip or soft toothbrush;
2. Rub in &/or massage in or apply on;
3. Circular motion preferred for massaging into oral tissues;
4. Leave on oral tissues for 1-3 minutes;
5. Rinse excess off with water;
6. Apply 3-4 times a day as indicated.

Recommendations for Use:

1. Use a designated toothbrush for this product.
2. **Preferred use after meals and snacks;**
3. Follow-up with your dentist for regular dental visits and care.
4. Use an extra soft toothbrush to massage gums. Apply toothbrush at an 45% angle with the tooth to the gums. Brush gently in a circular motion.
